A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, PROVIDING NO OBJECTION FOR KCG AVANTI HILLS, LP'S APPLICATION TO THE TEXAS DEPARTMENT OF HOUSING AND COMMUNITY AFFAIRS ("TDHCA") FOR NON-COMPETITIVE 4% HOUSING TAX **CREDITS** CONSTRUCTION FOR THE OF APPROXIMATELY 254-UNIT AGE RESTRICTED, SENIOR AFFORDABLE HOUSING DEVELOPMENT TO BE LOCATED AT OR ABOUT THE NORTHWEST CORNER OF EAST GLEN BOULEVARD AND CLAY MATHIS ROAD, IN ACCORDANCE WITH CHAPTER 2306 OF THE TEXAS GOVERNMENT CODE: AND AUTHORIZING THE CITY SECRETARY TO CERTIFY THE RESOLUTION TO THE TDHCA.

WHEREAS, KCG Avanti Hills, LP (the "Applicant"), has proposed the development of an approximately 254-unit age restricted, senior affordable housing development to be known as Avanti Hills and located at or about the northwest corner of East Glen Boulevard and Clay Mathis Road, in the City of Mesquite, Dallas County (the "Proposed Development"); and

WHEREAS, the Applicant has indicated that it intends to submit an application to the Texas Department of Housing and Community Affairs ("TDHCA") for 2025 Non-Competitive 4% Housing Tax Credits for the Proposed Development (the "Application"); and

WHEREAS, the City of Mesquite, Texas (the "City"), acting through its City Council as its governing body, desires to express that it does not object to the Application for the aforementioned Proposed Development.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

- (iv) After due consideration of the information provided by the Applicant and public comment, the City does not object to the proposed Application.
