

BARNES BRIDGE GROUND STORAGE TANKS REHABILITATION CITY OF MESQUITE CONTRACT NO. 2024-163

Change Order No. 1 April 4, 2025

Description of Change and Reason for Proposed Change

During the evaluation phase of the ground storage tanks, the tanks were not drained. However, once the tanks were drained and cleaned as part of the construction process, multiple issues were discovered. As a result, additional remediation work is required to extend the service life of the tanks. The following changes are included in this Change Order No. 1:

- 1. Additional remediation work for the <u>2 Million-Gallon Tank</u> includes concrete rust spot repair, floor drain pipe repair, wall drain pipe repair, and floor crack repair.
- 2. Additional remediation work for the <u>5 Million-Gallon Tank</u> includes concrete rust spot repair, floor crack repair, floor leak injection, replacement of 36-inch pipe brackets, and repair of the 8-inch sensing line.
- 3. This change order also includes a credit for using an alternative column repair method instead of the initially specified fiber-reinforced polymer repair.

The changes mentioned above will result in a cost increase, as follows:
