SUBJECT: Proposed items for purchase from State Seizure Account # SA17/18-350-03

The following items are proposed for purchase from the State seizure account:

1. Mobile Throw Phone for Negotiators \$18,000

This request is for the purchase of mobile throw phones for the hostage negotiations unit. This system replaces a hard wired throw phone purchased 12/29/2011 that is currently in use by the hostage negotiations team and has reached the end of its service life. The system has two mobile phones in tamper-proof cases that can be thrown into a hostage situation without risk of damaging the phone. The phone only allows calls from the command phone unit and will not make outside calls. The phone case has several concealed cameras that allow negotiators to see what is happening in a hostage situation. The cost includes two phones for deployment and two phones for negotiators so a secondary negotiator can monitor the calls. Also included is extra batteries and on-site training from the company.

2. Chemical Protective Equipment for Tactical Team \$25,000

This request is for the purchase of chemical protective equipment for the Tactical Team. This purchase will outfit the tactical team with Tyvek suites and accompanying equipment to secure hazardous environments such as fentanyl labs. The costs listed above include full body protection and specialized gas mask filters.

3. Back-up Pistols \$25,000

This request is for the purchase of backup pistols carried by sworn officers on and off duty. The purchase is for the upcoming year and consists of two different models to be issued on a limited basis.

| <p>This request is for the purchase of new Glock firearms and accessories to be issued to officers throughout the upcoming year as duty weapons. Several different holsters are included on this purchase as accessories.</p> | |
| 5. Magnet Forensics AXIOM | \$6,000 |

| <p>This request is for the purchase of two licenses of Magnet Forensics AXIOM. The computer lab has previously used Magnet Forensics IEF to forensically evaluate computers for digital evidence. AXIOM is Magnet Forensics new program, which will do everything that IEF will do, but also can be used on phones and some other personal electronics, expanding the labs ability to retrieve digital evidence.</p> | |
| 6. LPR System for Auto Theft | \$30,000 |

| <p>This request is for the purchase of a covert Vigilant license plate reader to be mounted in an unmarked pickup truck issued to the Auto Theft Section. The four-camera system is contained in a toolbox and mounted in the bed of the vehicle. The system automatically scans and runs stolen checks on vehicles and reports to the driver when a stolen vehicle is detected. The system also records the license plates scanned and keeps a date and time stamp of when and where the vehicle was detected. The Vigilant system is used often by detectives attempting to track down suspects.</p> | |
| 7. SRT Protective Suits | \$15,000 |

| <p>This request is for the purchase of 30 Sirchie TacCommander Riot Control Suits for the SRT Team. These suits are adjustable, on size fits all, suits that provide protection from blunt force trauma. The suits are capable of holding the rifle plates already issued to officers to provide ballistic protection.</p> | |
| 8. Ford Transit Van | \$70,000 |

| <p>This request is for the purchase of a Ford Transit Van for the tactical team. The van currently being used by the tactical team is too small to transport a full team with gear to warrants. This vehicle will allow the team to use only one vehicle for personnel and equipment and will allow extra equipment to be stored and available if needed at a critical incident. The van currently being used by the tactical team will be used by the SRT Team.</p> | |
| 9. Portable Radios | \$77,000 |

| <p>This request is for the purchase of 28 portable radios for the police department. The police department has issued all available radios to officers. These radios will be issued to newly hired officers and several will be kept in reserve for temporary issue to officers who have radios in need of maintenance.</p> | |
| 10. Trailer for Tactical Team | \$8,000 |

| <p>This request is for the purchase of an enclosed cargo trailer for the tactical team. The trailer will be used to store equipment that is not often needed, but is needed during critical incidents. The trailer will have shelving installed so gear will ride safely and securely to the scene or warrants and tactical callouts.</p> | |

11. Anti-Suicide Smocks

\$6,000

This request is for the purchase of anti-suicide smocks for the jail to issue to prisoners who have been identified as a suicide risk. The smocks are a tear-resistant single-piece outer garment that help prevent a detained individual from forming a noose with the garment to commit suicide. These are part of a suicide prevention program for the jail. Our currently utilized disposable anti-suicide suits are insufficient.

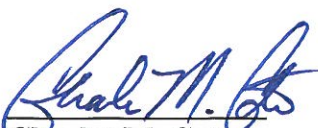
