Re: Regional Transportation Council Representation

Dear Mayors Childress, Taylor, and George:

The Regional Transportation Council (RTC) of the North Central Texas Council of Governments (NCTCOG) reappoints its members in June of even-numbered years. Our four municipalities are currently clustered together and are permitted to appoint one RTC representative to serve on behalf of the four-city cluster. Since 1978, the City of Mesquite has held the primary seat on the RTC due to its population. In accordance with the RTC bylaws, representation for clustered cities is based on population. The City of Mesquite's 2023 population accounts for more than 74 percent of the total 2023 population of the four municipalities combined.

Our current representation as approved in April 2024 consists of myself as the primary member and Councilmember Tandy Boroughs as the alternate member of the RTC. At this time, we are requesting to change the alternate member designation from Councilmember Tandy Boroughs to Mayor of Sunnyvale, Saji George for the remainder of the current term, which expires June 30, 2026.


