and that no person serve more than four (4) consecutive two-year terms as Councilmember and four (4) consecutive two-year terms as Mayor, for a total of eight (8) consecutive two-year terms combined, without a two-year break in service; provide for the establishment of the office of the City Attorney and clarify that the City Attorney shall exercise control conform certain City Attorney's office; to provisions actual/current practices; to conform certain provisions to State law and the City Code, correct terms, correct spelling, clarify language, provide gender-neutral references and make other technical amendments; prescribing the form and wording of the ballot propositions; further ordering a General Election to be held on May 5, 2018, for the purpose of electing a City Councilmember for Place 3, a City Councilmember for Place 4 and a City Councilmember for Place 5; providing for legal notice; and making provisions for the conduct of the elections.
