EXECUTIVE SESSION - COUNCIL CONFERENCE ROOM - 6:30 P.M.

Mayor Alemán announced that the City Council would meet in Executive Session pursuant to Section 551.071 of the Texas Government Code to conduct a private consultation with its attorney related to pending or contemplated litigation; a settlement offer; and issues in which there exists a duty of the City Attorney to the governmental body under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas (Agenda Item No. 14 and Receive update on City of Mesquite v. CC Hillcrest, LLC, Summit Hillcrest Apartments, Ltd, Hillcrest GP, LLC and 2119 Hillcrest St., Mesquite, Texas 75149 in rem, Cause No. DC-22-01764 – Filed 2-14-22; and in re CC Hillcrest, LLC, Case No. 22-31362-swe11 – Filed 7-29-22); whereupon, the City Council proceeded to meet in the Council Conference Room. Receive Neighborhood Services Environmental Code Division Council update.

Maria Martinez, Director of Neighborhood Services, presented the Environmental Code Division Council update. She stated that Fiscal Year (FY) 2022 statistics include 23,165 violations identified and addressed, 569 citations issued and 92 percent voluntary compliance was received. The top violations for FY 2022 include 4,970 trash and debris violations, 4,965 high grass and weeds violations and 2,527 nuisance and outdoor storage violations.

Ms. Martinez stated that Environmental Code Officers now have body worn cameras while out in the field. She stated that the HOME (Helping Others in Mesquite Everyday) Program is now operating from the Environmental Code Division and is active and accepting Code Inspector referrals.

2. Mr. Smith stated that the Mesquite Community Job Fair will be held on Saturday, 24, 2022, from 9:00 a.m. to Noon, at New Light Church, 1300 South Beltline Road. Staff from the City's Human Resources Department will be on-site with information regarding job openings at the City.

3. Mr. Boroughs stated that the City of Mesquite requires permits for most events that involve a large gathering of people on public property, as well as some events on private property. Any event that requires the closure of roads or restricts access to public property, such as a parade or fun run, will require a permit. 4. Ms. Vidler thanked Curt Cassidy, Director of Public Works, and his staff for assisting citizens with new water meter concerns.

5. Ms. Vidler stated that a District 3 Neighborhood Meeting will be held on Thursday, September 22, 2022, from 7:00 p.m. to 8:00 p.m., at Rugel Elementary School, 2701 Sybil Drive, and encouraged residents to attend.

6. Mr. Green encouraged citizens and community groups to participate in Trash Bash, hosted by Keep Mesquite Beautiful, Inc., on Saturday, September 24, 2022. Volunteers will clean up litter in various sites around the community.

7. Mr. Casper stated that National Night Out will be held on Tuesday, October 4, 2022. He encouraged residents to coordinate meetings in neighborhoods throughout the City.

8. Mayor Alemán stated that the Mesquite Business Retention and Expansion (BRE) Partnership will host a Manufacturing Day for the manufacturing and career and technical education student communities on Friday, October 14, 2022, from 7:30 a.m. to 2:00 p.m., at Vanguard High School, 4201 Faithon P. Lucas, Sr., Boulevard. Mesquite's Manufacturing Day aims to connect Mesquite Independent School District High School Juniors and Seniors, as well as Dallas College students, with local manufacturers and manufacturing opportunities.

9. Mayor Alemán stated that the trial for fallen Police Officer Richard Houston was held last week. The Defendant was found guilty of capital murder and sentenced to life in prison. He thanked the Mesquite Police Department for their interviews and testimony for the trial. He also thanked the Mesquite Police Department, Mesquite Fire Department and City staff for supporting the Houston family during the trial. Mayor Alemán stated that he is grateful for Police Chief David Gill and his staff who continue to strongly support the Houston family.

10. Mayor Alemán stated on Friday, September 23, 2022, there will be a special presentation to honor fallen Police Officer Travis Williams, who was tragically killed in the line of duty on September 23, 1974. A banner will be displayed outside of the Mesquite Police Headquarters during September in his honor.

11. Mayor Alemán thanked everyone who attended and participated in the 911 ceremony at Freedom Park on September 11, 2022.

12. Mayor Alemán stated that the Mesquite Economic Development Department announced that the City of Mesquite is ranked No. 3 among 29 cities in the Dallas Business Journal's list of North Texas Economic Development Agencies for 2021. Mesquite ranked behind Fort Worth and above Dallas with a total dollar volume of deals at \$451 million.

13. Mayor Alemán announced that the Texas Downtown Association has named two Mesquite nominees, Mesquite BBQ and Front Street Station, as statewide finalists in the President's Awards competition.

CONSENT AGENDA ITEM CONSIDERED SEPARATELY

11 Bid No. 2022-133 - Mesquite Paschall Park Odor Control. (Staff recommends award to Archer Western Construction, LLC and to authorize the City Manager to finalize and execute a contract in the amount of \$1,642,000.00 for construction of a permanent sanitary sewer odor control facility located in Paschall Park).

Mr. Boroughs stated that over the years, the City has received complaints regarding sewer odors from residents in Paschall Park Estates. The City has installed flapper valves on the resident's sewer lines and performed smoke tests in an effort to resolve the issue. This agenda item is for the construction of a permanent sanitary sewer odor control facility located within the boundaries of Paschall Park, which should alleviate this issue.

Mr. Boroughs moved to approve Bid No. 2022-133, Mesquite Paschall Park Odor Control, and authorize the City Manager to finalize and execute a contract in the amount of \$1,642,000.00 for construction of a permanent sanitary sewer odor control facility located at Paschall Park. Motion was seconded by Mr. Smith and approved unanimously.

OTHER BUSINESS

17 Consider cancelling the regular City Council meeting scheduled for Monday, September 26, 2022.

Mr. Green moved to cancel the regular City Council meeting scheduled for Monday, September 26, 2022. Motion was seconded by Ms. Anderson and approved unanimously.

PUBLIC HEARINGS

18 Conduct a public hearing and consider an ordinance for Zoning Application No. Z0722-0249, submitted by John LeFevers, Andrew Oakwood Investments, LLC, for a change of zoning from General Retail to General Retail with a Conditional Use Permit, to allow a carwash, located at 1601 West Bruton Road. (No responses in favor or in opposition to the application have been received from property owners within the statutory notification area. The Planning and Zoning Commission recommends approval with certain stipulations.)

A public hearing was held for Zoning Application No. Z0722-0249.

Jeff Armstrong, Director of Planning and Development Services, stated that in 1984, the City Council approved a Conditional Use Permit (CUP) for a self-service carwash located on the corner of West Bruton Road and Almond Drive. The carwash was constructed and operated until January 2018. Since then, the structure has remained in place but no business has taken place on the property. When a CUP is discontinued or ceases to operate for more than six months, the CUP terminates. Therefore, to reopen a carwash at this location requires approval of a new CUP.

Mr. Armstrong stated that the facility includes four wash bays and four vacuum stations. The previous business also included a retail component offering snacks in an enclosed building located at the south end of the vacuum bay structure. In addition to the carwash, the applicant proposes to reopen the retail snack portion of the business, offering pre-packaged foods and snow cones.

Mr. Armstrong stated that the minimum landscaping requirement for this property includes three trees and installation of an irrigation system.

Applicant John LeFevers stated he closed the carwash several years ago because he was working out of town. Now that he is retired, he would like to reopen the carwash. He stated that three trees will be planted at north end of the property. He would prefer to hand water the trees and not be required to install an irrigation system.

No one appeared regarding the proposed application.

Mr. Boroughs moved to approve Zoning Application No. 0722-0249, as recommended by the Planning and Zoning Commission, with the following stipulations:

1. Replatting of the entirety of property is required, including the undeveloped portion of the property to the north, upon sale of the property.

2. Ten percent landscape area is required in accordance with current landscape requirements of the MZO. However, no irrigation system will be required to be installed.

3. An outdoor seating area with trash receptacle is required as depicted in the approved site plan upon opening of any food or beverage sales on site.

4. Prior to the issuance of a building permit or a Certificate of Occupancy, an approved site plan is required to show that the property complies with current requirements of the MZO and the Engineering Design Manual.

5. The CUP is approved solely for the business owned by the applicant John LeFevers. It shall not be transferred or assignable to a different owner or business.

And to approve Ordinance No. 4987, AN ORDINANCE AMENDING THE MESQUITE ZONING ORDINANCE BY APPROVING A CHANGE OF ZONING FROM GENERAL RETAIL TO GENERAL RETAIL WITH A CONDITIONAL USE PERMIT ON PROPERTY LOCATED AT 1601 WEST BRUTON ROAD TO ALLOW A CARWASH SUBJECT TO CERTAIN STIPULATIONS; REPEALING ALL ORDINANCES IN CONFLICT WITH THE ORDINANCE; PROVIDING A SEVERABILITY PROVISIONS OF THIS CLAUSE; PROVIDING A PENALTY NOT TO EXCEED \$2,000.00; AND PROVIDING AN EFFECTIVE DATE. Motion was seconded by Ms. Vidler and approved unanimously. (Ordinance No. 4987 recorded in Ordinance Book No. 127.)
