AN ORDINANCE AMENDING THE MESQUITE ZONING ORDINANCE BY APPROVING A CHANGE OF ZONING PERMIT, FROM COMMERCIAL WITH SPECIAL ORDINANCE NO. 1027, WITHIN THE SKYLINE LOGISTICS HUB OVERLAY DISTRICT ("DISTRICT") TO COMMERCIAL WITH SPECIAL PERMIT, ORDINANCE NO. 1027, WITHIN THE DISTRICT, AND A CONDITIONAL USE PERMIT TO ALLOW A COIN-OPERATED AMUSEMENT GAMEROOM ON PROPERTY LOCATED AT 3828 EAST U.S. HIGHWAY 80; REPEALING ALL OTHER ORDINANCES IN CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A PENALTY NOT TO EXCEED \$2,000.00; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Planning and Zoning Commission and the City Council, in compliance with the Charter of the City of Mesquite, state laws and the zoning ordinance, have given the required notices and held the required public hearings regarding the rezoning of the subject property; and

WHEREAS, the City Council finds that it is in the public interest to grant this change in zoning.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

- SECTION 1. The subject property is described as being approximately .083 acres of land, platted as Associated Business Park, Lot 1, Block B, and located at 3828 East U.S. Highway 80 in the City of Mesquite, Dallas County, Texas (the "Property").
- SECTION 2. The Mesquite Zoning Ordinance is amended by approving a change of zoning for the Property from Commercial with Special Permit, Ordinance No. 1027, within the Skyline Logistics Hub Overlay District ("**District**") to Commercial with Special Permit, Ordinance No. 1027, within the District, and a Conditional Use Permit to allow a coin-operated amusement gameroom with the stipulation that there is a maximum of two coin-operated game machines.
- SECTION 3. All ordinances, or portions thereof, of the City of Mesquite in conflict with the provisions of this ordinance, to the extent of such conflict are hereby repealed; otherwise, they shall remain in full force and effect.
- SECTION 4. The Property shall be used only in the manner and for the purposes provided for by the Mesquite Zoning Ordinance, as amended.
- Should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional, the remaining provisions of this ordinance shall remain in full force and effect.

SECTION 6. Any violation of the provisions or terms of this Ordinance by any "person," as defined in Mesquite City Code, Chapter 1, Section 1-2, shall be deemed a Class C Misdemeanor criminal offense, and upon conviction thereof, shall be subject to a penalty of fine, or any other general penalties, as provided in Mesquite Zoning Ordinance, Part 5, 5-100, Section 5-103 (General Penalties), or successor and as amended.

<u>SECTION 7.</u> This Ordinance shall be published in the City's official newspaper in accordance with Mesquite City Charter, Article IV, <u>Section 24</u>.

SECTION 8. This Ordinance shall take effect and be in force from and after five days after publication.
