PUBLIC HEARINGS

9. ZONING APPLICATION NO. Z0722-0247

Conduct a public hearing and consider Zoning Application No. Z0722-0247 submitted by Scott Harvel for a Zoning Change from Commercial to Commercial with a Conditional Use Permit to allow the outdoor display of used vehicles, located at 2828 IH 30.

PRESENTATION

Manager of Planning & Zoning Garrett Langford presented to the Commission.

DISCUSSION

Commissioner McBride asked about temporary signage. Mr. Langford explained that there is a pole sign already there that can be used to advertise. Mr. Langford said he will check on the ordinance regarding temporary signs.

APPLICANT

Alexandra Harvel 2828 IH 30 gave a brief presentation and presented the Commission with pictures of the kind of car inventory they will have as the outdoor display. The commissioners asked about the security, the number of employees, and if they will be carrying the financing notes on the vehicles. Ms. Harvel stated that the proposed site already has security lighting and cameras, they will have 4 employees, and they can carry the financing on the vehicles.

PUBLIC HEARING

Chairman Melend opened the public hearing. No one came to speak.

ACTION

Commissioner Arnold made a motion to **APPROVE** with staff's recommendations; Commissioner Screws seconded; the motion carried 7-0.

10. ZONING APPLICATION NO. Z0722-0248

Conduct a public hearing and consider Zoning Application No. Z0722-0248 submitted by WRA Architects, Inc. on behalf of Mesquite Independent School District, for a Zoning Change from Agricultural and Planned Development – Single Family (Ordinance No. 3887) to Agricultural and Planned Development – Single Family (Ordinance No. 3887) with a Conditional Use Permit to allow a school use on the property, located at 3300 E. Cartwright Road.

PRESENTATION

Manager of Planning & Zoning Garrett Langford presented to the Commission.

DISCUSSION

Eric Gallt with the City of Mesquite Traffic Engineering Division explained that this is a concept plan and will change as the construction gets started. The traffic flow will be a priority for the City as construction proceeds. Mr. Gallt understands the concerns with the traffic flow and stated that will be monitored closely.

APPLICANT

Graham Baumann 12377 Merit, Dallas, TX, with WRA Architects presented to the Commission the plans for the 9th-grade center. Mr. Baumann stated that the traffic flow is a priority and will comply with the City of Mesquite's Traffic Engineering.

PUBLIC HEARING

Chairman Melend opened the public hearing. No one came to speak.

ACTION

Commissioner McBride made a motion to APPROVE with staff's recommendations; Vice-Chair Lynn seconded; the motion carried 7-0.

11. ZONING APPLICATION NO. Z0822-0253

Conduct a public hearing and consider Zoning Application No. Z0822-0253 submitted by Scott Rohman, 42 BP LP, for a Zoning Change from Industrial to Planned Development – Industrial to allow an industrial business park with modifications, generally located to the west of Lawson Road, south of E. Scyene Road, and east of the Mesquite Airport. STAFF RECOMMENDS POSTPONEMENT OF ITEM NO. 11 TO A DATE CERTAIN OF OCTOBER 10, 2022.

PRESENTATION

Manager of Planning & Zoning Garrett Langford explained that the applicant requested that this be postponed.

PUBLIC HEARING

Chairman Melend opened the public hearing.

Alana Martinez 1515 Lawson Rd. came up to speak. Ms. Martinez stated that she never received any notice and feels that the City of Mesquite is ignoring her street. Mr. Langford addressed her concerns by stating that her street and area are not in the City Limits of Mesquite, so therefore, she would not get public notice. Ms. Martinez was told by the Chair that she is welcome to come to the public hearing and voice her concerns. Ms. Martinez does not think it's fair.

Tasha Martinez 1515 Lawson Rd. has concerns that the new construction will cause additional flooding. No one else came to speak. The public hearing was left open to the next meeting date.

ACTION

Commissioner Ross made a motion to **POSTPONE** to a date certain of October 10, 2022; Commissioner Arnold seconded; the motion carried 7-0.
