A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, AUTHORIZING THE CITY MANAGER TO **SPECIFIC FINALIZE** AND **EXECUTE** THE **PROJECT** AGREEMENT AMENDING THE MASTER AGREEMENT **CAPITAL** GOVERNING MAJOR **TRANSPORTATION** IMPROVEMENT PROGRAM (MCIP) WITH DALLAS COUNTY FOR THE PURPOSE OF TRANSPORTATION IMPROVEMENTS ON SKYLINE DRIVE, MCIP PROJECT 11903, FROM TOWN EAST BOULEVARD TO PEACHTREE ROAD.

WHEREAS, on April 19, 2021, pursuant to Resolution No. 19-2021, the City Council approved the Master Agreement Governing Major Capital Improvement Program between the City of Mesquite and Dallas County providing for the construction of transportation improvements on roadways inside Dallas County with the City of Mesquite that are on the North Central Texas Council of Governments Regional Thoroughfare Plan; and

WHEREAS, Dallas County Major Capital Improvement Program Project 11903 will make transportation improvements on Skyline Drive from Town East Boulevard to Peachtree Road; and

WHEREAS, Dallas County has allocated \$5,300,000.00 to fund approximately 50 percent of the paving and drainage costs; and

WHEREAS, the City will be responsible for the remaining portion of paving and drainage costs along with 100 percent of utility improvements and amenities for an estimated total of \$6,700,000.00; and

WHEREAS, Chapter 791 of the Texas Government Code and Texas Transportation Code, Article 251, provides authorization for local governments to contract with each other for the performance of governmental functions and services, and joint funding of road or street projects.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the City Council authorizes the City Manager to finalize and execute the Project Specific Agreement to the Master Agreement Governing Major Capital Improvement Program with Dallas County for the purpose of Public Transportation Improvements on Skyline Drive from Town East Boulevard to Peachtree Road, Dallas County Major Capital Improvement Program Project 11903, and authorizing the City Manager to execute the PSA with a City project funding commitment in the estimated amount of \$6,700,000.00.
