AN ORDINANCE OF THE CITY OF MESQUITE, TEXAS, AMENDING CHAPTER 9 OF THE CODE OF THE CITY OF MESOUITE, TEXAS, AS AMENDED, BY PROVIDING CERTAIN ADDITIONS AND DELETIONS UNDER SECTIONS 9-147(1)(d), 9-147(1)(e) AND 9-147(2) THEREBY PROVIDING A SCHOOL ZONE FOR FRASIER MIDDLE SCHOOL ALONG PEACHTREE ROAD, MEMORIAL BOULEVARD AND SCYENE ROAD (SH-352); PROVIDING A REPEALER CLAUSE; PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED (\$200.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EFFECTIVE DATE THEREOF.
