AN ORDINANCE OF THE CITY OF MESOUITE, TEXAS. AMENDING ZONING THE MESQUITE **ORDINANCE** ADOPTED ON SEPTEMBER 4, 1973, AND RECODIFIED ON NOVEMBER 21, 1988, SO AS TO APPROVE A CHANGE OF ZONING FROM GENERAL RETAIL TO **PLANNED** DEVELOPMENT - GENERAL RETAIL WITH A CONDITIONAL USE PERMIT ON PROPERTY LOCATED AT 3600 GUS THOMASSON ROAD, SUITE 125 THEREBY ALLOWING AN INDOOR RECREATIONAL FACILITY SUBJECT TO CERTAIN STIPULATIONS: REPEALING ALL **ORDINANCES** CONFLICT WITH THE PROVISIONS OF THIS ORDINANCE: PROVIDING A SEVERABILITY CLAUSE; PROVIDING FOR A PENALTY NOT TO EXCEED TWO THOUSAND (\$2,000.00) DOLLARS FOR EACH OFFENSE; AND DECLARING AN EMERGENCY.

WHEREAS, the Planning and Zoning Commission of the City of Mesquite and the governing body of the City of Mesquite, in compliance with the Charter of the City of Mesquite and State laws with reference to granting of zoning changes under the Zoning Ordinance Regulations and Zoning Map, have given the requisite notices by publication and otherwise, and after holding due hearings and affording a full and fair hearing to all property owners generally and to the persons interested and situated in the area, the City of Mesquite is of the opinion that the change of zoning may be granted herein.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the Mesquite Zoning Ordinance adopted on September 4, 1973, and recodified on November 21, 1988, be and the same is hereby amended by amending the Zoning Map of the City of Mesquite so as to approve a change of zoning on property zoned General Retail to Planned Development - General Retail with a Conditional Use Permit ("CUP") thereby allowing an indoor recreational facility subject to the following stipulations:

- 1. The uses permitted shall be limited to those uses permitted in the General Retail (GR) zoning district subject to the same requirements applicable in the GR district, except that a CUP may be granted to allow indoor recreation facilities and such use may be permitted within 100 feet of a residential district.
- 2. A CUP for indoor recreation is hereby approved with the following conditions:
 - a. This CUP shall be limited to Suite 125, a building containing approximately 15,457 square feet.
 - b. The CUP is granted specifically to Kids Empire Dallas Mesquite, LLC, doing business as Kids Empire and is not assignable or transferrable.

That the subject property is located at 3600 Gus Thomasson Road, Suite 125, and is described as being in the Towne Crossing Addition, Block C, Lot 1.

SECTION 2. That all ordinances, or portions thereof, of the City of Mesquite in conflict with the provisions of this ordinance, to the extent of such conflict are hereby repealed. To the extent that such ordinances or portions thereof are not in conflict herewith, the same shall remain in full force and effect.

SECTION 3. That the property described in Section 1 of this ordinance shall be used only in the manner and for the purposes provided for by the Mesquite Zoning Ordinance.

SECTION 4. That should any word, sentence, clause, paragraph or provision of this ordinance be held to be invalid or unconstitutional, the remaining provisions of this ordinance shall remain in full force and effect.

SECTION 5. That any person (as defined in Chapter 1, Section 1-2 of the Code of the City of Mesquite, Texas, as amended) violating any of the provisions or terms of this ordinance shall be deemed to be guilty of a Class C Misdemeanor and upon conviction thereof, shall be subject to a fine not to exceed Two Thousand (\$2,000.00) Dollars for each offense, provided, however, if the maximum penalty provided for by this ordinance for an offense is greater than the maximum penalty provided for the same offense under the laws of the State of Texas, the maximum penalty for violation of this ordinance for such offense shall be the maximum penalty provided by the laws of the State of Texas. Each day or portion of a day any violation of this ordinance continues shall constitute a separate offense.

SECTION 6. That the property described in Section 1 of this ordinance requires that it be given the above classification in order to permit its proper development and in order to protect the public interest, comfort and general welfare of the City of Mesquite, creates an urgency and emergency for the preservation of the public health, safety and welfare, and requires that this ordinance shall take effect immediately from and after its passage.
