A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, AUTHORIZING THE FILING OF AN APPLICATION FOR AN AMOUNT NOT TO EXCEED \$1,099,865.00 FOR FEDERAL FUNDS UNDER THE HOUSING AND COMMUNITY DEVELOPMENT ACT; APPROVING AND ADOPTING THE PROGRAM YEAR 2018-19 COMMUNITY DEVELOPMENT BLOCK GRANT ANNUAL ACTION PLAN, INCLUDING THE PROGRAM ALLOCATION; AND DESIGNATING THE CITY MANAGER AS CHIEF EXECUTIVE OFFICER AND AUTHORIZED REPRESENTATIVE FOR THE PURPOSE OF GIVING REQUIRED ASSURANCES AND ACTING IN CONNECTION WITH SAID APPLICATION.

WHEREAS, the City of Mesquite, Texas ("City"), is entitled to certain funds under the Housing and Community Development Act in an amount not to exceed \$1,099,865.00 in Community Development Block Grant ("CDBG") Funds for the 2018-19 program year as shown in Exhibit "A" attached hereto; and

WHEREAS, on June 18, 2018, the City Council held the first of two public hearings to receive comments regarding the preliminary budget for the 2018-19 CDBG program and allocations; and

WHEREAS, a 30-day comment period occurred beginning on June 25 through July 25, 2018, to receive public comments regarding the 2018-19 budget and Annual Action Plan; and

WHEREAS, on August 6, 2018, the City Council held the second of two public hearings to receive comments regarding the preliminary budget for the 2018-19 CDBG program and allocations; and

WHEREAS, the Mesquite City Council has considered the suggestions and recommendations that were raised at the hearings and provided during the comment period for the expenditure of the funds; and

WHEREAS, it is in the public interest of the citizens of Mesquite that application be made for such funds and that the Program Year 2018-19 CDBG Annual Action Plan, including the Program Year 2018-19 Program Allocation, be adopted.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the Program Year 2018-19 Community Development Block Grant Program Annual Action Plan, including the Program Year 2018-19 Program Allocation, attached hereto as Exhibit "A," is hereby approved and adopted.

SECTION 2. That the City Manager is hereby authorized to file an application for funds under the Housing and Community Development Act on behalf of the City.


