**Subject:** Proposed School zone removals

Good afternoon Mr. Huckaby,

In an effort to update the city code concerning "no longer needed" school zones, after the relocation of (a) Florence ES, (b) Hanby ES, and (c) Seabourn ES, staff is proposing the removal of the school zones from the following locations. Before we take any action, we are requesting your staff's input/recommendation concerning our proposal. We understand that removing a school zone is a sensitive issue, and we wanted to make sure that our decision is based on sound judgement and observations from both us and your staff.

We want to implement this in a two phase process – first phase is to remove the 20 MPH school zone and leave the existing crosswalk signs, and crosswalks, in place, and if there are no negative response, taking it to the next phase of removing the crosswalk signs. If there is a mid-block crosswalk involved, both the signs as well as the crosswalk will be removed. We plan to place this as an agenda item for city council consideration in January, 2019, if there is concurrence from the district staff. If the district staff feels any additional school zones are needed, please let me know, so that we can evaluate them and add them as new school zones to the agenda. Let me know if you need additional information.

1. Gleneagle Drive from Oates Drive to Whitson Way (Florence ES)

2. Cascade Street from Grubb Drive to Lee Street(Hanby)
3. Grubb Drive from Embassy Drive to Grubb Circle (Hanby)
4. Lee Street from Grubb Drive to Cascade Street (Hanby)
5. Sandy Lane from Fielding Drive to Peachtree Road (Seabourn)
