Chairman Abraham called the meeting to order and declared a quorum present. Alternates Claude McBride and Jerome Geisler were seated in place of Yolanda Shepard and Sherry Williams.

I. APPROVAL OF THE MINUTES OF THE MAY 28, 2019 MEETING

Ms. Vidler made a motion to accept the minutes as submitted. Ms. Sheila Lynn seconded. The motion passed unanimously.

II. ZONING CASE

The City Council may approve a different zoning district than the one requested, except that the different district will not (1) have a maximum structure height or density that is higher than the one requested; or (2) change the uses to solely nonresidential uses when the request is for solely residential uses or vice versa.

A. Conduct a public hearing and consider Application No. Z0119-0083 submitted by City of Mesquite for a Zoning Change to amend Planned Development – Mixed Use Ordinance No. 3967 to allow changes to the uses permitted on property described as being 60.31 +/- acres of land situated in the Daniel Tanner Survey, Abstract No. 1426, City of Mesquite, Dallas County, Texas, located at 21100 IH 635.

Manager of Planning & Zoning Garrett Langford briefed the Commissioners. Chair opened the public hearing. No one came up to speak. Chair closed the public hearing. Ms. Vidler made a motion to approve as presented. Ms. Anderson seconded. The motion passed unanimously.

B. Conduct a public hearing and consider amending the Mesquite Zoning Ordinance, Section 3-203, Schedule of Permitted Uses, within the SS, Service Station District to add additional uses as permitted. (ZTA 2019-02)

Principal Planner Johnna Matthews briefed the Commissioners. Chair opened the public hearing. Abdul Awa approached the lecturn and spoke in favor of the proposed text amendment as it would allow his business to open. No one else came up to speak. Chair closed the public hearing. Mr. Gustof made a motion to approve. Ms. Vidler seconded. The motion passed unanimously.

- 3. Applications No. Z0419-0091 and No. Z0419-0092 for a change of zoning to Planned Development Industrial to allow an industrial multi-tenant business park, located at 1650 Republic Parkway and 1201 IH 30 were **approved.**
