A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, APPROVING AND ADOPTING THE 2020-2024 COMMUNITY DEVELOPMENT BLOCK GRANT CONSOLIDATED PLAN AND THE PROGRAM YEAR 2020-21 COMMUNITY DEVELOPMENT BLOCK GRANT ANNUAL ACTION PLAN.

WHEREAS, the U. S. Department of Housing and Urban Development ("HUD") requires entitlement communities to prepare a three- to five-year consolidated plan as well as an annual action plan to receive federal housing and community development funding; and

WHEREAS, the City of Mesquite (the "City") is an entitlement city scheduled to receive certain funds under the Housing and Community Development Act annually; and

WHEREAS, the 2020-2024 Community Development Block Grant ("CDBG") Consolidated Plan includes citizen input and strategic planning to establish a unified vision on how the funds are to be allocated in response to community needs voiced through public hearings, public comments, community surveys, stakeholder input sessions and an analysis of impediments to fair housing; and

WHEREAS, the 2020-2024 CDBG Consolidated Plan includes the Program Year 2020-21 CDBG Annual Action Plan (collectively the "Plans") stating how the City plans to allocate the CDBG funds for Fiscal Year 2020; and

WHEREAS, the City published a public notice on August 6, 2020, in the Daily Commercial Record newspaper for a comment period for the Plans from August 10 - 14, 2020, and made the Plans available for public viewing; and

WHEREAS, the City conducted public hearings and accepted public comments; and

WHEREAS, the Mesquite City Council has considered the suggestions and recommendations raised through public hearings, public comments, citizen input and strategic planning.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the 2020-2024 Community Development Block Grant Consolidated Plan which includes the Program Year 2020-21 Community Development Block Grant Annual Action Plan for the City of Mesquite, a copy of which shall be maintained in the City Secretary's office as an original document, is hereby adopted and approved for submission.
