A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS, AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO ACCEPT A CORONAVIRUS RESPONSE AND RELIEF SUPPLEMENTAL APPROPRIATIONS ACT GRANT FROM THE TEXAS DEPARTMENT OF TRANSPORTATION IN THE MAXIMUM AMOUNT OF \$57,162.00 TO PREVENT, PREPARE FOR, AND RESPOND TO THE IMPACTS OF THE COVID-19 PUBLIC HEALTH EMERGENCY ON AIRPORTS AND THE AIR TRAFFIC CONTROL TOWERS OPERATION; AND AUTHORIZING THE CITY MANAGER OR HIS DESIGNEE TO FINALIZE AND EXECUTE ALL NECESSARY DOCUMENTS RELATIVE TO THE ACCEPTANCE OF SUCH GRANT.

WHEREAS, on May 3, 2021, the City Council of the City of Mesquite, Texas, approved Ordinance No. 4858 relative to the continuation of the proclamation of a local state of disaster, authorizing additional authority related to the local state of disaster, and adopting and approving certain rules to protect the health of persons in the City of Mesquite; and

WHEREAS, the U.S. Department of Transportation has made Coronavirus Response and Relief Supplemental Appropriations Act ("CRRSAA") grants available to general aviation airports through the Texas Department of Transportation; and

WHEREAS, the Texas Department of Transportation acts as agent for the U.S. Department of Transportation for the purposes of applying for, receiving and disbursing all aviation grant funds, including CRRSAA grants, and for the administration of contracts necessary for the implementation of these improvements; and

WHEREAS, the City of Mesquite has received an offer of financial assistance in the form of a 100 percent grant in the maximum amount of \$57,162.00 from the Texas Department of Transportation from CRRSAA grant funds; and

WHEREAS, funds can be used to cover revenue shortfalls, capital expenditures, and/or general operating expenses of the Mesquite Metro Airport, including payroll, and other purposes for which airport revenues may be lawfully used.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MESQUITE, TEXAS:

SECTION 1. That the City Manager or his designee is hereby authorized to apply for and accept a Coronavirus Response and Relief Supplemental Appropriations Act grant from the Texas Department of Transportation in the maximum amount of \$57,162.00 to prevent, prepare for, and respond to the impacts of the COVID-19 public health emergency on airport operations. The grant reimburses the City of Mesquite for 100 percent of qualifying expenses and revenue shortfalls and requires no matching funds.
