Appoint Jeff Jones as a member to the Towne Centre Tax Increment Finance Reinvestment Zone No. Two Board of Directors for a term to expire December 31, 2018.

The City Council adopted Ordinance No. 3257 establishing a Board of Directors for the Towne Centre Tax Increment Finance (TIF) Reinvestment Zone No. Two on September 21, 1998.

City Council appoints four members to the Towne Centre TIF Board to serve two-year terms and the Mesquite Independent School District (MISD) Board of Trustees appoints three members to serve two-year terms. The board members whose terms expire on December 31, 2018, are:
