Staff recommends the purchase of one pumper truck equipped with a fully enclosed cab, a 1,500 gallon per minute (GPM) pump, a 750-gallon water tank and ladders. Spartan Emergency Response Vehicles (Spartan ERV) is the pumper manufacturer and is represented by Metro Fire Apparatus Specialists, Inc., of Houston, Texas.

The pumper is scheduled for replacement in compliance with the Mesquite Fire Department's Apparatus Replacement Program. This pumper will replace the pumper at Fire Station 1.

The pumper is listed as an S-180 pumper. The S-180 pumpers have a 180-day delivery window and are preengineered to accommodate the common features utilized by most fire departments. The fire department is taking the opportunity to evaluate the S-180 pumper with a goal of lowering the overall cost and maintenance downtime of the pumper fleet.

A portion of the balance of the budgeted amount will be used to buy non-specified loose equipment, radios and mount the Mobile Data Computer and tools.
