On March 23, 2020, the Mayor of the City of Mesquite issued a Declaration of Local State of Disaster For Public Health Emergency relating to the Coronavirus pandemic. The Mesquite City Council has since adopted subsequent ordinances thereby continuing the Mayor's Declaration of Local Disaster for Public Health Emergency relating to COVID-19.

The CDC has stated that multiple variants of the virus that causes COVID-19 have been documented in the United States and globally during this pandemic. The CDC reports, *"these particular variants seem to spread more easily and quickly than other variants, which may lead to more cases of COVID-19. An increase in the number of cases will put more strain on healthcare resources, lead to more hospitalizations, and potentially*

*more deaths.”*

On July 1, 2021, Texas Governor Greg Abbott issued a proclamation renewing the statewide declaration stating that the novel coronavirus (COVID-19) poses an imminent threat of disaster for all counties in Texas.

Because COVID-19 and its variants continue to spread, extraordinary measures must be continued to contain COVID-19 and prevent its spread throughout the State and the City of Mesquite while safely keeping Texas businesses open in accordance with the guidance provided by the President of the United States, Texas Governor Gregg Abbott, Dallas County, and Kaufman County.

Staff recommends approval of the ordinance.
